Jack Youra is happy to report that on February 14, 2025 we completed the 2 repairs on our pool. It was a sweet surprise that the second leak was less costly than our first. Both leaks were on the suction side of the plumbing, with the first requiring digging up the concrete to facilitate a more detailed repair in a PVC fitting. In addition, the Club has proactively purchased some new pump room equipment to bring us into compliance with current codes, as well as a cover for the spa. This cover will help maintain the water temperature and prevent evaporation which will result in a cost savings to utilities bills. When using the spa just simply pull back the cover like a bed sheet and neatly drape over a few chairs. Then kindly spread it back over the spa when you are finished.
