Four of the five Club officers (President, Treasurer, Secretary and Director-at-Large) must be elected by December. Without officers, business stops. For example, it will be impossible to pay our bills, enroll new members, do major repairs, pay property taxes, renew contracts, schedule events and very much more.

Our Club is a valuable community asset. Good people must step up to lead it.

Our Bylaws spell out a process to elect new officers. That begins officially in September, only a month away, but can and should start now. The process is simple, you need only call one of the officers listed above to get started.

Annual Dues Reminder: WTBM By-Laws III.D.

Annual Dues shall be determined at the October Membership meeting and may be paid in equal installments, which are due on the first of the month. A late charge of fifteen dollars (\$15.00) will be added for payments that are delinquent more than ten (10) days. Additionally, should a member be more than ten (10) days delinquent in paying dues three (3) times within the same fiscal year (December through November), they will be subject to removal of membership at the discretion of the Board.

Online bill pay is available to anyone that has a checking account. If you forget to pay your dues on time or run out of checks, why not set up your account for bill pay to WTBM. Our address is on the top of this page on the newsletter every month. We strongly suggest setting the "send on date" as the 20th of the month prior to which it is due. EXAMPLE: Paying for September, schedule the send out date as August 20th.
